PURPOSE: The Swisher County Commissioners Court will discuss and take possible action regarding a First Amendment to the Tax Abatement Agreement with Hornet Solar LLC, pursuant to Chapter 312 of the Texas Tax Code.

Property Owner and Applicant for Tax Abatement: Hornet Solar LLC

Proposed Reinvestment Zone: Hornet Solar LLC Reinvestment Zone

Property in Proposed Reinvestment Zone: See attached map and legal description provided in Exhibit "A" attached hereto and incorporated herein for all purposes.

Anticipated Improvements: The general description of the nature of the improvements included in the agreement is as follows:

Hornet Solar LLC anticipates constructing a solar power facility with a roughly 310 megawatts (AC) of Nameplate Capacity located in the Reinvestment Zone. Improvements may include (but are not limited to) approximately 1,568,000 solar modules/panels; approximately 164 inverters; metal mounting system with tracking capabilities; battery or battery system; underground conduit; communications cables and electric system wiring; combiner boxes; project substation including breakers; transformer and meters; overhead transmission lines; operations and maintenance facility; fencing; telephone and internet communication system, and meteorological equipment to measure solar irradiation and weather conditions.

Summary of Proposed Amendments: The First Amendment to the Tax Abatement Agreement would increase the megawatts from 310 (AC) of Nameplate Capacity to 600 (AC) of Nameplate Capacity and extend the Commercial Operations date so that the Owner agrees that the Project shall achieve Commercial Operations on or before December 31, 2025.

Estimated Cost of the Improvements: The estimated cost of the improvements being contemplated by Hornet Solar LLC is approximately \$488,000,000.00.
