




## NOTICE OF CONVENING OF EARLY VOTING BALLOT BOARD


To the Early Voting Clerk and Custodian of Ballot Box Key,

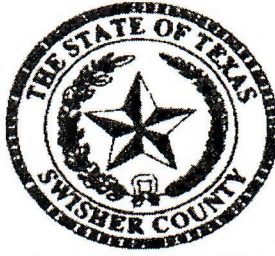
